Boarding Requirements:

All pets must have been examined by a certified veterinarian within the past year.

All pets must be up to date on DHPP (dogs), FVRCP (cats) and Rabies vaccination.

Dogs must be current on Bordetella (kennel cough) vaccination.

A negative fecal examination within six months.

An approved Flea and Tick product applied within the last 30 days (Frontline Plus, K9 Advantix and Revolution. If pet is on only a flea product, a tick product will need to be added.)

If live fleas are seen upon admission, your pet will be treated at your expense.

Pets are fed Science Diet Adult maintenance food. If your pet is on a Prescription diet it is recommended that you bring it in with them or it will be dispensed at the regular charge.

Food containers **MUST BE LABELED UPON ADMISSION**. We ask that you do not bring personal items such as blankets and bowls as we have all the necessary items to accommodate your pet.

Additional fees apply for administering medication and supplements.

All medications must be in their original container with a label that is legible. Any controlled medications will be counted at check in and check out to ensure accuracy.

I also acknowledge that no guarantees have been made except reasonable precautions against injury, escape or illness. I acknowledge that my pet will not have overnight supervision. Should above animal become sick or injured during the stay he/she will be treated by the veterinarian on duty and I am responsible for charges. Should an emergency arise the owner/agent will be contacted at the provided phone number. I understand there is a risk of exposure and contracting kennel cough or other airborne illnesses while housed in the AMC Pet Resort. The Bordetella, Distemper, and Parainfluenza vaccines do not prevent all upper respiratory infections. If additional visits are needed to address any concerns I assume responsibility for any medications or diagnostics that the doctor deems medically necessary.

Multiple Pet Housing

If I wish my pets be housed together in AMC's Pet Resort, I understand that there is some risk in housing multiple pets in the same area and feel that this risk is limited and am willing to accept this. If at any point the staff of AMC feels that any of my pets are at risk, they may separate them.

OWNER RELEASE:

I have read and understand the information above. I understand that full payment is due at the time of check out. If above animal is not picked up within 10 days of scheduled check out date, said animal is assumed abandoned and Animal Medical Center is the authorized agent for animal.

Hurricane Season

During the hours preceding the storm and those after the end of the storm, there may be no one in attendance at this hospital. Due to the nature of this emergency period the ability to return to these premises is beyond our control. The pets here will be attended to as soon as humanly possible following the storm. The Animal Medical Center makes no guarantees or promises to the amount of time pets in our care will be left alone. No guarantees are made to the safety and well being of pets left in the care of Animal Medical Center during this boarding period. In the case of severe weather or other emergency, it may be necessary to cage multiple animals together. This will only be done in a truly serious emergency situation and only under the Doctors advisement. I have read and understand the above information and agree to release Animal Medical Center and their staff members from any liability related to the care and well being of my pets left during this emergency period.

We offer a number of additional services to enhance your pet's enjoyment while staying with us. Please ask our Pet Resort staff if you have any questions or special requests!

Charges accrue on a per night basis. If requested, we provide bathing services at owner's expense. If your pet stays with us for seven nights or more they will get a complimentary bath.

Sunday pick up is available for a non-refundable fee of \$20.00. Pick up time is between 9:00 AM and 11:00 AM Sunday morning and payment is due at check in.
